

TAX LEVY ORDINANCE
WHITE OAK TOWNSHIP ROAD AND BRIDGE DISTRICT
ORDINANCE NO. 2024-04

An ordinance levying taxes for all road purposes for White Oak Township Road and Bridge District McLean County, Illinois, for the tax year 2024 , collectable in 2025.

BE IT ORDAINED by the Board of Trustees of White Oak Township Road and Bridge District, McLean County, Illinois as follows:

SECTION 1: That the Board of Trustees White Oak Township Road and Bridge District hereby determines and declares that the sum of seventy-two thousand one hundred Dollars (\$72,100) are hereby levied upon all property subject to taxation within the White Oak Township Road and Bridge District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- Road & Bridge Fund Audit Fund
- Joint Bridge Fund Social Security Fund
- Insurance Fund Equipment & Building Fund
- Permanent Road Fund

for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
