

**TAX LEVY ORDINANCE**  
**WHITE OAK TOWNSHIP**  
**ORDINANCE No. 2024-04**

An ordinance levying taxes for all town purposes for White Oak Township, McLean County, Illinois, for the tax year 2024 collectable in 2025.

BE IT ORDAINED by the Board of Trustees of White Oak Township, McLean County, Illinois, as follows:

SECTION 1: That the sum of twenty-seven thousand four hundred Dollars (\$27,400.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
