**Meeting Minutes**

  - A. Onuma moved to approve the minutes as presented. P. Braffet seconded. Motion carries with 4 ayes and 0 nays. R. Lorimor abstained due to absence.

**Township Supervisor Report**

- Trustee Randy Lorimor was sworn in.
- Carlock hosted the annual clean up day on May 3<sup>rd</sup>. C. Metsker moved to pay for the dumpsters totaling \$792.70. P. Braffet seconded. Motion carries unanimously.

- Renee Brucker sent a list of items needed for the audit.
- After review and discussion, P. Braffet moved to approve the 2025-2026 Township levy as presented. R. Lorimor seconded. Motion carries unanimously.
- After review and discussion, C. Metsker moved to approve the 2025-2026 Road & Bridge levy as presented. A. Onuma seconded. Motion carries unanimously.
- After review and discussion, R. Lorimor moved to approve the Township portion of the 2025-2026 Cemetery levy totaling \$2,200. A. Onuma seconded. Motion carries unanimously.
- The cemetery board will vote on their part of the levy after the budget hearings on June 18<sup>th</sup> at 6:00pm.

**Township Community Building**
